### INTRODUCTION BY MR. HOOTIE ADAM-EOC DIRECTOR

• Mr. Adam updated all governmental entities/representatives with the latest information regarding Hurricane Nate from the National Weather Service. At this time, he still anticipates a 4-6 ft. storm surge; that watch is in effect. At this time evacuations were still on a voluntary basis for low-lying areas, but he anticipated that that will be upgraded to mandatory evacuation shortly and verbally received each City's and the County's authorization to notify residents at such time he deemed necessary. He said at this time he did not know what time the eye would go over land, but the storm is currently moving at 21 mph., noting it should make landfall very late Saturday night or early Sunday morning; and high tide will be at 1:00 am. After further discussion, he answered all questions asked.
